### Management & Resident Agree As Follows:

- 1) Permission is given for resident's pet, described below, to be kept within said premises, as stated above. Resident understands and agrees that such permission was given based on compliance with the following conditions: (a) when pet is taken in or out of the premises, it will be kept on a leash or caged and under full control at all times; and (b) when walking pet, it will be kept away from public places, lawns, and sidewalks of all residences in neighborhood or buildings in complex, whichever is applicable herein; and (c) resident will be responsible for cleaning up resident's pet droppings; and (d) resident shall be liable for all damage caused by pet to said premises or grounds therein or thereon. Management will bill resident for damage caused by pet, and the bill shall be paid as additional rent as and due no later than with the following month's rent.
- 2) If in the sole discretion of management, said pet annoys, bothers, or is allowed to annoy or bother other residents of the neighborhood or complex, or the public within the area or becomes a threat to public health or safety, then management will send a written notice to the resident and within five (5) days after receipt of such notice resident shall remove said pet from the premises. Failure to comply with the written notice could result in legal remedies, including, but not limited to, termination of the lease agreement to which this exhibit belongs.
- 3) Resident agrees to pay **\$350 as a non-refundable pet fee** for the privilege of maintaining said pet on management's premises. These pet fees do not waive resident's responsibility for all damages caused by pet. Resident agrees that only the pet named and described below will occupy the premises and resident understands that no additional or different pet is authorized under this agreement.
- 4) Resident may have no more than one dog or cat or two (2) birds. In the sole discretion of management as to what types or breeds of pets will be allowed but breeds of pets known to be highly aggressive or dangerous such as, but not limited to, bulldogs, pit bulldogs or pit terriers, Rottweiler, Dobermans, and fighting game birds, are prohibited on premises. No other animals, reptiles, rodents, or insects are allowed on or in premises, including but not limited to livestock or farm animals, exotic animals, pigs, skunks, ferrets, monkeys, snakes, lizards, turtles, frogs, hamsters, guinea pigs, and gerbils.
- 5) No pet offspring are allowed to be birthed or housed in or on the premises.
- 6) Resident must provide proof of vaccination of pet, where same is required by law, for communicable diseases prevalent in species of pet, including, but not limited to, rabies.
- 7) Dogs must weigh no more than 75 pounds at maturity.
- 8) Dogs must have a crate to be put in for maintenance visits and/or house showings.**
- 9) Fish tanks may be no larger than five (5) gallons.
- 10) Birds must be caged at all times.
- 11) Resident agrees to abide by these terms and by all applicable laws regarding the keeping of animals or pets in the area of the premises, including but not limited to, leash laws, licensing laws, and laws regarding vaccinations and inoculations.
