- 1. Apply Online:** [www.AthensRealEstateGroup.com](http://www.AthensRealEstateGroup.com) - There is a green 'Apply Online' on the home page. E-mail a picture of your government issued ID (driver's license or passport) to [leasing@AthensRealEstateGroup.com](mailto:leasing@AthensRealEstateGroup.com). Everyone in the group must fill out this application and send a copy of their ID to move forward to the next step and receive the lease agreement.
- 2. Parental Guarantee Form or \$30 Application Fee with Sufficient Proof of Income** – *Each tenant's application must be approved by providing one of the two items;*
  - Parental guarantee - which can be found on our website under the 'Forms' section and can be e-mailed to [Leasing@AthensRealEstateGroup.com](mailto:Leasing@AthensRealEstateGroup.com), or
  - Pay a \$30 application fee with your most recent month's proof of income (you must show your most recent 4 weeks of income). The monthly income requirement is *at least* 2.5 times the monthly rent amount in gross pay (after taxes). The application fee must be paid at our office, there is no way to make this application fee payment online.
- 3. Sign the lease** – Designate one of the applicants as the 'Special Stipulations' person; our main point of contact for the house. They are also the one to receive the whole refund of the security deposit, if one is due, after the move out inspection and is responsible for disbursing it among the other roommates. The lease will be sent out via **DocuSign** in an e-mail from [StephanieP@AthenRealEstateGroup.com](mailto:StephanieP@AthenRealEstateGroup.com); you create an online account to review and sign it electronically.
- 4. Pay Security Deposit & Pet Deposit** – The security deposit is the amount of one month's rent and is refundable within 30 days after the move out inspection/last day of the lease agreement. The security deposit and refundable pet deposit must be paid by check, cashier's check, or money order only and is due at time of signing the lease. *\*The Non-refundable pet fee must be paid separately by check, money order, or cashier's check and is also due at time of signing the lease.\** Please call the office with questions regarding pet deposits.
